


Percent distribution of adults by tobacco use, Himachal Pradesh 2016-17



About GATS

The Global Adult Tobacco Survey (GATS) is a global standard for systematically monitoring adult tobacco use (smoking and smokeless) and tracking key tobacco control indicators.

GATS is a household survey of persons 15 years of age and older conducted in all 30 states of India and two Union Territories. The first round of GATS was conducted between June 2009 and January 2010. The second round of GATS was conducted between August 2016 to February 2017 by Tata Institute of Social Sciences (TISS), Mumbai for Ministry of Health & Family Welfare (MoHFW), Government of India. A multi-stage sample design was used for both rounds of GATS. From each of the sampled households, one household member 15 years of age and older was randomly selected for individual interview. In Himachal Pradesh, a total of 1002 males and 1545 females were interviewed during August -September 2016.



GATS 2 Highlights

- 26.7% of men, 1.6% of women and 14.2% of all adults currently smoke tobacco.
- 6.1% of men, 0.1% of women and 3.1% of all adults currently use smokeless tobacco.
- 30.4% of men, 1.7% of women and 16.1% of all adults either smoke tobacco and/or use smokeless tobacco.
- From GATS 1 to GATS 2, there has been a significant decrease in the prevalence of smoking by 4.1 percentage points and smokeless tobacco use by 1.4 percentage point. The prevalence of any tobacco use has decreased significantly by five percentage points from 21.2% in GATS 1 to 16.1 in GATS 2.
- *Bidi* is the most commonly used tobacco product; 12.6% of adults smoke *bidi*.
- In GATS 2 none of the person aged 15-17 reported tobaccouse.
- The mean age at initiation of tobacco use has decreased from 20.5 years in GATS 1 to 20.2 years in GATS 2.
- 53.3% of smokers were advised by a health care provider to quit smoking and 27.9% of smokeless tobacco users were advised by a health care provider to quit smokeless tobacco use.
- One-fourth of all adults who worked indoors were exposed to second-hand smoke at their workplace.
- 12.0% of all adults were exposed to second-hand smoke at any public place⁷.
- 79.9% of cigarette smokers and 74.7% of *bidi* smokers thought of quitting smoking because of warning label. 66.3% of smokeless tobacco users thought of quitting smokeless tobacco use because of warning label.








Any tobacco use





Percent distribution of adults by tobacco use status, GATS Himachal Pradesh 2016-17




Prevalence of most commonly used tobacco products among all adults, GATS Himachal Pradesh 2016-17
(Figures in Percentages)






Percent distribution of daily tobacco users by time to first tobacco use of the day, GATS Himachal Pradesh 2016-17
