


Percent distribution of adults by tobacco use, Meghalaya 2016-17



## **About GATS**

The Global Adult Tobacco Survey (GATS) is a global standard for systematically monitoring adult tobacco use (smoking and smokeless) and tracking key tobacco control indicators.

GATS is a household survey of persons 15 years of age and older conducted in all 30 states of India and two Union Territories. The first round of GATS was conducted between June 2009 and January 2010. The second round of GATS was conducted between August 2016 to February 2017 by Tata Institute of Social Sciences (TISS), Mumbai for Ministry of Health & Family Welfare (MoHFW), Government of India. A multi-stage sample design was used for both rounds of GATS. From each of the sampled households, one household member 15 years of age and older was randomly selected for individual interview. In Meghalaya, a total of 798 males and 784 females were interviewed during November 2016.



## GATS 2 Highlights

- 53.7% of men, 9.5% of women and 31.6% of all adults currently smoke tobacco.
- 11.6% of men, 29.1% of women and 20.3% of all adults currently use smokeless tobacco.
- 59.8% of men, 34.2% of women and 47.0% of all adults either smoke tobacco and/or use smokeless tobacco.
- From GATS 1 to GATS 2, there has been a significant decrease in the prevalence of smoking by 4.1 percentage points and smokeless tobacco use by 7.9 percentage points. The prevalence of any tobacco use has decreased significantly from 55.2% in GATS 1 to 47.0% in GATS 2.
- Cigarette and *bidi* are the most commonly used tobacco products. 23.4% of adults smoke cigarette and 17.2% smoke *bidi*.
- The prevalence of tobacco use among persons aged 15-17 has decreased from 26.4% in GATS 1 to 12.6% in GATS 2.
- The mean age at initiation of tobacco use has increased from 17.0 years in GATS 1 to 17.5 years in GATS 2.
- 41.6% of smokers were advised by a health care provider to quit smoking and 53.8% of smokeless tobacco users were advised by a health care provider to quit use of smokeless tobacco.
- 45.7% of all adults who worked indoors were exposed to second-hand smoke at their workplace.
- 28.3% of adults were exposed to second-hand smoke at any public place<sup>7</sup>.
- 52.9% of cigarette smokers and 45.4% of *bidi* smokers thought of quitting smoking because of warning label. 45.7% of smokeless tobacco users thought of quitting smokeless tobacco use because of warning label.









Age at initiation of tobacco use, smoking and smokeless tobacco use, GATS Meghalaya, 2009-10 and 2016-17

Prevalence of smoking and smokeless tobacco use by age group,








Prevalence of most commonly used tobacco products among all adults, GATS Meghalaya 2016-17 (Figures in Percentages)





Percent distribution of daily tobacco users by time to first tobacco use of the day, GATS Meghalaya 2016-17


