


Percent distribution of adults by tobacco use, Tamil Nadu 2016-17



About GATS

The Global Adult Tobacco Survey (GATS) is a global standard for systematically monitoring adult tobacco use (smoking and smokeless) and tracking key tobacco control indicators.

GATS is a household survey of persons 15 years of age and older conducted in all 30 states of India and two Union Territories. The first round of GATS was conducted between June 2009 and January 2010. The second round of GATS was conducted between August 2016 to February 2017 by Tata Institute of Social Sciences (TISS), Mumbai for Ministry of Health & Family Welfare (MoHFW), Government of India. A multi-stage sample design was used for both rounds of GATS. From each of the sampled households, one household member 15 years of age and older was randomly selected for individual interview. In Tamil Nadu, a total of 1371 males and 1544 females were interviewed during October -November 2016.



GATS 2 Highlights

- 21.1% of men, 0.1% of women and 10.5% of all adults currently smoke tobacco.
- 11.9% of men, 9.3% of women and 10.6% of all adults currently use smokeless tobacco.
- 31.0% of men, 9.3% of women and 20.0% of all adults either smoke tobacco and/or use smokeless tobacco.
- From GATS 1 to GATS 2, the prevalence of smoking has increased by 0.9 percentage points however, the increase is not significant. The prevalence of smokeless tobacco has significantly increased by 2.5 percentage points. The prevalence of any tobacco use has also significantly increased by 3.8 percentage points from 16.2% in GATS 1 to 20.0% in GATS 2.
- Cigarette and betel quid with tobacco are the two most commonly used tobacco products; 6.3% of adults smoke cigarette and 6.0% use betel quid with tobacco.
- Similar to GATS 1, in GATS 2 also none of the person aged 15-17 reported using tobacco.
- The mean age at initiation of tobacco use has increased from 18.5 years in GATS 1 to 20.6 years in GATS 2.
- 73.8% of smokers were advised by a health care provider to quit smoking and 59.1% of smokeless tobacco users were advised by a health care provider to quit smokeless tobacco use.
- One in every five adult who worked indoors were exposed to second-hand smoke at the workplace.
- 12.1% of all adult were exposed to second-hand smoke at any public place⁷.
- 76.1% of cigarette smokers and 59.5% of *bidi* smokers thought of quitting smoking because of warning label. 42.5% of smokeless tobacco users thought of quitting smokeless tobacco use because of warning label.









Age at initiation of tobacco use, smoking and smokeless tobacco use, GATS Tamil Nadu, 2009-10 and 2016-17 (mean age in years)








Prevalence of most commonly used tobacco products among all adults, GATS Tamil Nadu 2016-17




Percent distribution of daily tobacco users by time to first tobacco use of the day, GATS Tamil Nadu 2016-17
